1. INTRODUCTION

The Centre for Development Economics (CDE) was established as a non-profit society in 1992. It began effectively functioning from early 1993, with the full range of activities picking up only in late 1993 after it received an endowment grant from the Ministry of Finance, Government of India. It is located at the Delhi School of Economics. The Centre promotes collaboration with other institutions and individuals interested in economics and development policy. It acts as a research adjunct to the Department of Economics, augmenting the infrastructure and providing research support. It hosts visitors, organizes conferences and workshops, houses faculty research projects, offers fellowships to masters and doctoral students, and engages with the government on matters of economic policy.

The CDE also runs an active seminar series, holds occasional public lectures in collaboration with the Department of Economics, and publishes a working paper series to disseminate research by its members and their collaborators. A nationally recognized flagship event of CDE is its annual Winter School. It comprises invited lectures by internationally renowned economists including Nobel Laureates, and contributed papers by early career researchers who get an opportunity to be mentored by experts.

The Centre has a well-equipped computer lab with latest software and hardware for meeting the research and training needs of MA, MPhil and PhD programs of the Department of Economics. It also has an archive of major data sets and a library for use by local researchers. The Centre is managed by a Council of eight members, elected for a two-year term from among the members of CDE, who are all faculty and ex-faculty of the Department of Economics.

The activities of CDE are funded by interest income from two endowment grants from the Ministry of Finance, from project income, and from contributions by individuals and institutions interested in promoting the goals of the Centre. In addition to the endowment grant in 1993, the Centre received a corpus fund from the Ministry of Finance in 2012 for hosting visitors and awarding fellowships for doctoral and post-doctoral students. It has also received project support from various ministries of the Government of India, the Reserve Bank of India, ICSSR, the European Union, the Bill and Melinda Gates Foundation, and the Research Council of Norway, among others.

During the period April 2020 to March 2021, members of the department continued to contribute to the field of economics and development studies in significant ways. Several faculty members published their research in leading national and international academic journals. They also participated in policy debates through writings in popular journals and newspapers. The Department remains a UGC Centre of Advanced Study. For the eighth consecutive year, it was ranked the highest amongst university economics departments in India by RePEc, a global electronic archive of working and publications in economics papers (https://ideas.repec.org/top/top.india.html). Faculty members also participated in several national and international conferences. During the year under review, despite the dislocation caused by the Covid-19 pandemic, the CDE organized its annual Winter School and maintained its weekly seminar series that brought in many distinguished speakers.

2. CONFERENCES AND WORKSHOPS

WINTER SCHOOL 2020

Winter School 2020 was jointly organized by the Centre for Development Economics (CDE), the Econometric Society, and the Department of Economics at the Delhi School of Economics (DSE), with financial support from EXIM Bank and others. It was held over the period December 14-17, 2020 in virtual mode.

Participants in the Winter School were selected largely from graduate students and junior faculty who responded to a Call for Papers. From about 250 high-quality submissions, 162 were chosen, and their authors were invited to attend the lectures as well as present their papers as contributed, conference talks.

There were approximately fifty-one participants from Indian institutions, ten from other Asian countries, thirty-seven from Europe, and sixty-four from America and Australia. Their papers spanned a broad set of fields, including Microeconomic Theory, Game Theory, Macroeconomics, Econometric Theory, Labour Economics, Industrial Organization, International Trade, Choice Theory, Gender Discrimination, Auction, Market Design, Information, Development Economics, Environmental Economics, Education, Pandemic, Monetary Policy, Political Economy, and Public Economics. Thanks to a generous grant from the Econometric Society, prizes were awarded to the best four papers.

4. FELLOWSHIPS AND SCHOLARSHIPS

POST-DOCTORAL FELLOWSHIP

The CDE instituted a post-doctoral fellowship in 2015. Recent PhD graduates as well as those who have submitted their PhD thesis but are yet to be awarded their degree are eligible. The fellowship helps the candidate engage in research before holding a formal academic position. During 2019-20 the fellowship was awarded to **Dr. Dyotona Dasgupta (ISI, New Delhi).** Due to the prevailing situation on account of the Covid-19 pandemic, it was not possible to host a post-doctoral fellow during 2020-21.

DOCTORAL FELLOWSHIPS

The CDE offers monthly stipends to meritorious doctoral candidates who are not in receipt of any other financial support. The fellowship is offered to one student from each cohort for a period of up to five years.

KRISHNA RAJ TRAVEL FELLOWSHIPS

In 2006, the Sameeksha Trust established the Krishna Raj Summer Travel Fellowships, in memory of the longest serving editor of Economic and Political Weekly (EPW). It has been housed at CDE since its initiation. Under this programme masters students from Economics, Sociology and Geography conduct fieldwork-based short research projects, either individually or in groups. Inter-disciplinary research collaborations are particularly encouraged. This research is conducted in the summer vacation and is followed by a written report and presentation. Some of the best papers from this fellowship have been published in the EPW over the years. Due to the prevailing situation which made it impossible to send students out for fieldwork, the fellowships were not awarded in 2020-21.

M.A. SCHOLARSHIPS

CDE houses the Suresh Tendulkar Fund from which two masters scholarships are awarded annually in memory of the late Prof. Tendulkar. In 2019, the Arjun and Jayashree Sengupta Scholarship was endowed by Mrs. Jayashree Sengupta, in memory of her husband Prof. Arjun Sengupta. It is to be awarded every year to a woman student in the first year of the M.A. class. After Mrs Sengupta passed away in 2020, the scholarship was renamed in both their names at the request of their daughter, Prof. Madhura Sengupta. These scholarships are awarded in consultation with the Department of Economics.

PUBLIC POLICY RESEARCH SUPPORT GRANT

The two objectives of the BMGF grant have been to (a) build capacity and (b) generate new findings in the field of public economics, especially related to health, inequality and gender. The project was due to close in October 2020 but has been extended to December 2021 in view of the difficulties in continuing project activities during the pandemic.

Over the course of the past year, two book chapters have been written related to public policy in the context of the pandemic, one by Mausumi Das and the other by Parikshit Ghosh. These a part of an edited collection on the pandemic. The grant has funded the curation of data on the COVID-19 data portal hosted in collaboration with Siva Athreya in Bangalore. This has been accessed by many researchers and there has also been active engagement with the Karnataka government on their surveys and providing them with tools that find inconsistencies in government data sources. In addition, the grant has supported research on the Apni Beti Apna Dhan program in Haryana on the age of marriage.

INTERNATIONAL TRADE, UNEVEN GAINS AND THE ROLE OF ICTS

This work proposes to investigate whether access to ICTs reduces uneven gains from trade between regions, locations and income groups. Better understanding of the distributional impact of international trade is one of the prime tasks pursued in the recent literature of international economics. Following classical trade theorems, unambiguously, all individuals are supposed to get a pie from this gain. However, the question remains about the nature of the distribution of this

gain. Under heterogeneity and imperfect markets, the benefit from trade across individuals depends on the extent of heterogeneity and the degree of market imperfections (Melitz, 2003; Neary, 2016). However, ICTs innovations offer knowledge dissemination effectively and ease the functioning of markets by reducing transactions costs (Goldfarb and Tucker, 2019). One set of the literature shows that the ICTs have reduced the disparity. According to the Global Information Technology Report 2015, using data for 86 countries from 1980 to 2011, a 10 % increase in broadband penetration results in a 1.35 (1.19) % increase in GDP growth in the developing countries (developed economies). According to another set of literature, access to ICTs is not distributed equally across various individuals between income groups, regions, locations due to the variation of accessibility and affordability among them. Thus, the digital divide turns to be a factor limiting social wellbeing. If the access to ICTs systematically varies widely across groups, trade gains must be further uneven. If the lagged groups of people are benefited more than the rest, the gains would be even and pro-poor. Therefore, this research aims, (i) to explore the mechanism and show evidence on uneven gains from trade across regions, locations and individuals due to the uneven access to the markets and ICTs (Information and Communication Technologies), and (ii) to investigate the interaction effect of ICTs innovations and trade integration on the bilateral flows between India and Japan.

DOES PRIVATIZATION IMPROVE QUALITY OF ROADS? EVIDENCE FROM INDIA

Does private participation improve quality of roads? The project research aims to examine this question and various issues by examining Public Private Partnerships (PPPs) in road construction. Many highway (interstate road) projects in India have been built with private sector firms in the dominant role for building and maintenance of the roads. In a typical 'private' road, the contractor firms take responsibility to build the roads. The contractor firms are required to fund the project upfront. Moreover, the contractors are responsible for the upkeep of the roads during operation and maintenance phase of the project. In other words, private roads are built by delegating to the contracting firms most of engineering, control and management's decision related to building and maintenance of road assets, though the government retains de-jure the ownership rights over the roads. The project investigates the following issues related to privatization of roads. Are private highways better maintained than public highways? Why might PPP roads be better maintained in India? Do PPP contractors expend effort to destroy values of substitute facilities? What are the key take-aways from the Indian experience with PPPs from a policy view point?

CHALLENGING INEQUALITIES: AN INDO-EUROPEAN PERSPECTIVE

This project is based across four countries: India, UK, Norway and France, under the aegis of the EU-India Platform for the Social Sciences and the Humanities (EQUIP). The funding for the Indian component comes from the Indian Council for Social Science Research. Multiple researchers are working collaboratively on a range of sub-themes under the overall theme of inequality, such as measurement of inequality, attitudes towards inequality and fairness, and policies to mitigate inequalities.

Ashwini Deshpande (in collaboration with Veronique Gille and Rajesh Ramachandran) is working on an experiment to gauge attitudes towards affirmative action in order to understand whether beneficiaries are stigmatised on account of their group identity or because of preferential treatment. The project also seeks to understand if beneficiaries of class or means- based AA are as stigmatised by their peers as those receiving group based preferential treatment.

Abhiroop Mukhopadhyay is working on spatial inequalities. This project sought to calculate and understand drivers of local inequalities. Predictions of these spatial inequalities have been completed using machine learningand step-wise regression prediction methods. The latter was found to do better given the data in India. The village level inequalities, predicted by our model, are being currently validated using SECC village data that reports measures of income for one year of the period of our study. Once completed, the project will enter its final phase of understanding the drivers of these inequalities.

Arunava Sen (with Nicolas Gravel and Sarvesh Bandhu) is working on Theoretical Measures of Segregation. Segregation is obviously an important aspect of social relations in a society. It has however, received less theoretical attention than for instance, various forms of inequality. The project is working on developing a segregation index, which would indicate the "lack of interaction" between communities. The authors are working on analysing the relationships between concrete measures of segregation.

DISAGGREGATED INDUSTRY LEVEL PRODUCTIVITY ANALYSIS FOR INDIA: THE KLEMS APPROACH

The objective of the project is measurement and analysis of factor productivity in 27 industries comprising the Indian economy since 1980-81. The project uses the KLEMS methodology developed by Dale Jorgenson (Harvard University) and his associates, as part of the World KLEMS Initiative, which has been implemented in many countries across the world. Datasets on measures of output and factor inputs for the years 1980-81 onwards are being constructed for 27 industries, broad sectors and the total economy, using official data sources, such as NAS (National Accounts Statistics), ASI (Annual Survey of Industries), NSS Employment-Unemployment Surveys/Periodic Labour Force Surveys and Input-Output Tables (CSO).
