1. INTRODUCTION

The Centre for Development Economics (CDE) was established as a non-profit society in 1992. It began effectively functioning from early 1993, with the full range of activities picking up only in late 1993 after it received an endowment grant from the Ministry of Finance, Government of India. It is located at the Delhi School of Economics. The Centre promotes collaboration with other institutions and individuals interested in economics and development policy. It acts as a research adjunct to the Department of Economics, augmenting the infrastructure and providing research support. It hosts visitors, organizes conferences and workshops, houses faculty research projects, offers fellowships to masters and doctoral students, and engages with the government on matters of economic policy. The CDE also runs an active seminar series, holds occasional public lectures in collaboration with the Department of Economics, and publishes a working paper series to disseminate research by its members and their collaborators. A nationally recognized flagship event of CDE is its annual Winter School. It comprises invited lectures by internationally renowned economists including Nobel Laureates, and contributed papers by early career researchers who get an opportunity to be mentored by experts. The Centre has a well-equipped computer lab with the latest software and hardware for meeting the research and training needs of MA, MPhil and PhD programs of the Department of Economics. It also has an archive of major data sets and a library for use by local researchers. The Centre is managed by a Council of eight members, elected for a two-year term from among the members of CDE, who are all faculty and ex-faculty of the Department of Economics.

The activities of CDE are funded by interest income from two endowment grants from the Ministry of Finance, project income, and contributions by individuals and institutions interested in promoting the goals of the Centre. In addition to the endowment grant in 1993, the Centre received a corpus fund from the Ministry of Finance in 2012 for hosting visitors and awarding fellowships for doctoral and post-doctoral students. It has also received project support from various ministries of the Government of India, the Reserve Bank of India, ICSSR, the European Union, the Bill and Melinda Gates Foundation, and the Research Council of Norway, among others.

During the period from April 2023 to March 2024, members of the department continued to contribute to the field of economics and development studies in significant ways. Several faculty members published their research in leading national and international academic journals. They also participated in policy debates by writing in popular journals and newspapers. The Department remains a UGC Centre of Advanced Study. For the ninth consecutive year, it was ranked the highest amongst university economics departments in India by RePEc, a global electronic archive of working papers and publications in economics (https://ideas.repec.org/top/top.india.html). Faculty members also participated in several national and international conferences. During the year under review, despite the dislocation caused by the COVID-19 pandemic, the CDE organized its annual Winter School and maintained its weekly seminar series that brought in many distinguished speakers.

2. CONFERENCES AND WORKSHOPS

WINTER SCHOOL 2023

The Centre for Development Economics (CDE), Delhi School of Economics organizes its annual conference, Winter School, every year, bringing together students, researchers and faculty from diverse _fields of research and corners of India and abroad. Since 2018, the event has been hosted in collaboration with the Econometric Society. Winter School 2023 was held during December 14-16, 2023. It consisted of lectures by invited speakers and contributed talks by other participants.

INVITED TALK

Each of the invited speakers - John Wooders (NYU Abu Dhabi), Jordi Gali (CREi and Universitat Pompeu Fabra) and Joel Mokyr (Northwestern University), delivered two lectures, providing perspective and surveying the latest research in their field of expertise.

John Wooder's lectures focused on empirically testing game theory, particularly in mixed strategy games, using data obtained from laboratory experiments and the field. Jordi Gali offered insights into explaining economic fluctuations from the Neoclassical and New Keynesian perspectives. During his presentations, Joel Mokyr delved into global history to explain the 'Great Divergence'. The recordings of these lectures are available at:

CONTRIBUTED TALKS

The Winter School also hosted selected young scholars from across the country, who attended the invited lectures, presented their own research and received feedback on it. A call for papers was issued for the same. In response, the Winter School received 229 submissions. Approximately 130 papers were submitted from India, around 50 from the USA, and about 20 from the UK, with smaller numbers contributed from the other countries.

Membership of the Econometric Society was mandatory for paper submission.

All submissions underwent a screening and an internal reviewing process conducted by the Delhi School of Economics faculty members. Out of the 229 submissions, 89 accepted papers were finally presented across 36 thematic sessions. Professionals and scholars from prestigious institutions and universities, including the Delhi School of Economics, were invited to moderate these thematic sessions. Each talk was allotted 20 minutes, followed by 10 minutes of interaction

AUDIENCE

In addition to the invited speakers and those delivering contributed talks, the Winter School hosted approximately 100 registered attendees - predominantly research scholars and faculty members affiliated with various academic and research institutions in India. On average, more than 100-120 participants attended the invited lectures, and each parallel session drew an audience of around 25-30 participants. To enhance the convenience and comfort of the Winter School attendees, we provided free on-campus accommodation to 39 paper presenters, mostly young scholars.

BEST PAPER AWARDS

From the set of papers presented at the Winter School 2023, the three invited speakers selected four papers respectively for the \Best Paper Award" under the young scholars' initiative by the Econometric Society. Following is the list of paper awardees of Winter School 2023:

WORKSHOPS

1. Growth, Development and Productivity - 75 Years of Indian Experiences

The economy witnessed a significant transformation from almost zero growth in the preindependence period during 1900-1950 to the Hindu rate of growth of 3.5% in the first three decades
of post-independence India to a higher level in the later period. But, the growth rate has seen its ups
and downs and has slowed down in recent years. The role of policies that affected productivity
growth in the transition continues to be debated. Though the economy has witnessed a significant
improvement in economic development during the past 75 years since independence, the number of
development outcomes (e.g., poverty, informality, decent employment, and inequality) that seems to
have been influenced by the way productivity growth has progressed are bothering the scholars and
policy-makers engaged in the development debate. The post-independence period of the Indian
economy, commencing from the inception of planning in 1950 to the onset of the pandemic crisis
in the 2020s, was characterised by a massive improvement over pre-independence performance
coupled with some avoidable inadequacies, particularly in terms of incentives and institutional
structures and punctuated with droughts, natural disasters, wars, epidemics, and oil crises. This
workshop presents 27 papers on some of these issues by leading country scholars.

2. YOUNG SCHOLAR SEMINAR & WORKSHOP

A two-day Young Scholar Seminar was held on March 16 and 17, 2024. The first day of the event was dedicated to the themes of agriculture, development, microeconomics, and trade, as well as a plenary session on rural development initiatives in contemporary India. The event's second day was a workshop on Big data and Machine learning in economics. The event saw participation from various institutions like the Institute of Economic Growth, Indian Institute of Technology Delhi, Indian Institute of Technology Jodhpur, The Energy and Resource Institute, Azim Prem Ji University, OP Jindal Global University, NABARD and Dr B. R. Ambedkar University.

3. WORKSHOP ON "FINDING OF THE SHORT-TERM EMPIRICAL PROJECT ON THE EVALUATION: STUDY OF AYUSHMAN BHARAT IN RURAL HARYANA"

A one-day workshop based on the 'Finding of the Short-term Empirical Project on the Evaluative Study of Ayushman Bharat in Rural Haryana' was held at the Centre for Development Economics, Delhi School of Economics, University of Delhi, on March 6, 2024. The event was funded by the Indian Council of Social Science Research (ICSSR).

3. FELLOWSHIPS AND SCHOLARSHIPS

3.1. VISITOR/POST-DOCTORAL FELLOWSHIP

The CDE instituted a visitor/post-doctoral fellowship in 2015. Recent PhD graduates and those who have submitted their PhD thesis but are yet to be awarded their degree are eligible. The fellowship helps the candidate engage in research before holding a formal academic position. During 2023-24, the fellowship was awarded to **Ms. Chinmayi Srikanth** (Indian Institute of Management Kozhikode).

3.2. DOCTORAL FELLOWSHIPS

The CDE offers monthly stipends to meritorious doctoral candidates who are not receiving any other financial support. The fellowship is offered to one student from each cohort for up to five years. During the financial year 2023-24, the fellowship was awarded to Ms Pratishtha, Ms Mukta Jain, Ms K. Varsha, Ms Parul and Mr Ridwan Sheikh.

3.3. KRISHNA RAJ TRAVEL FELLOWSHIPS

In 2006, the Sameeksha Trust established the Krishna Raj Summer Travel Fellowships in memory of the longest-serving editor of Economic and Political Weekly (EPW). It has been housed at CDE since its initiation. Under this program, master's students in Economics, Sociology, and Geography conduct fieldwork-based short research projects individually or in groups. Inter- disciplinary research collaborations are particularly encouraged. This research is conducted during the summer vacation, followed by a written report and presentation. Some of the best papers from this fellowship have been published in the EPW over the years. Due to the prevailing situation that made sending students out for fieldwork impossible, the fellowships were not awarded in 2023-24.

3.4. M.A. SCHOLARSHIPS

CDE houses the Suresh Tendulkar Fund, from which two master's scholarships are awarded annually in memory of the late Prof. Tendulkar. In 2019, the Arjun and Jayashree Sengupta Scholarship was endowed by Mrs. Jayashree Sengupta in memory of her husband, Prof. Arjun Sengupta. It will be awarded yearly to a woman student in the first year of the M.A. class. 4. JOURNALS

INDIAN ECONOMIC REVIEW

Indian Economic Review, the journal of the Department of Economics, Delhi School of Economics, published 48 articles in 2023, including 1 Winter School Lecture and 3 book reviews. There were 93,826 downloads of articles in 2023. A total of 436 submissions were made, and 28 days were taken for the first decision.

IER <u>June 2023 issue</u>'s lead article, "Economics with a biological foundation" by Aldo Rustichini, is based on three lectures he delivered in the 2022 Winter School at the Delhi School of Economics. In 2023, along with the regular issues in June and December, IER is proud to have published two special issues.

The first special issue, titled "Current Themes in Economics", was guest-edited by **Joydeep Bhattacharya** of Iowa State University. The issue brings together a selection of papers by Pranab Bardhan, Dilip Mookherjee, Maitreesh Ghatak, Sayantan Ghosal, Sujata Visaria and many others. The second special issue titled "Macroeconomic Policy in Turbulent Times in EMEs" was guest-edited by **Kundan Kishor** of the University of Wisconsin–Milwaukee, Alexandru Minnea of the University Clermont Auvergne, and **Gurnain Pasricha** of the IMF. 5.1 DOES PRIVATIZATION IMPROVE QUALITY OF ROADS?

5.1 DOES PRIVATIZATION IMPROVE QUALITY OF ROADS?

Does private participation improve quality of roads? The project research aims to examine this question and various issues by examining Public Private Partnerships (PPPs) in road construction. Many highway (interstate road) projects in India have been built with private sector firms in the dominant role for building and maintenance of the roads. In a typical 'private' road, the contractor firms take responsibility to build the roads. The contractor firms are required to fund the project upfront. Moreover, the contractors are responsible for the upkeep of the roads during operation and maintenance phase of the project. In other words, private roads are built by delegating to the contracting firms most of engineering, control and management's decision related to building and maintenance of road assets, though the government retains de-jure the ownership rights over the roads. The project investigates the following issues related to privatization of roads. Are private highways better maintained than public highways? Why might PPP roads be better maintained in India? Do PPP contractors expend effort to destroy values of substitute facilities? What are the key take-aways from the Indian experience with PPPs from a policy view point?

5.2 Relationship between Income, Wealth and Tax payment in India

The project research aims to examine the relationship between wealth and the income reported to the tax authorities. To this end, we will estimate the income levels missing from the ITR files. We also examine the relationship between the wealth and tax payment for different categories of wealth. The project research has the following objectives:

- 1. To estimate the total income of the wealthiest Indians
- 2. To estimate the ratio of the 'total income' to the 'wealth', for different classes of wealth
- 3. To study the income reporting behaviour of the different categories of wealth by estimating the ratio of the 'total income reported to the tax department' to the 'wealth', for different classes of wealth
- 4. To study the reporting of the taxable income by different categories of wealth by estimating the ratio of the 'total-taxed-income' to the wealth, for different classes of wealth.
- 5. To study the reporting of the taxable income by different professions by estimating their ratio of the 'total-taxed-income' to the wealth.

5.3 STUDY VACCINE MARKET MODELS

The grant is being used to fund research on policies for providing universal access to affordable vaccines while providing incentives to vaccine manufacturers to invest in capacity and research and development. The theoretical research considers endogenous entry in single object procurement auctions with asymmetric suppliers. The potential suppliers decide to enter the auction before realizing their per-unit cost. Suppliers incur a fixed cost for entry into the auction. We characterize the optimal procurement auction in such an environment. We then study a two-period model, where a single object is procured in every period from the same potential set of suppliers. In the first period, suppliers are symmetric but suppliers who win the contract in the first period get cost (distribution) advantage in the second period. We apply our result to derive sufficient conditions on how cost distribution changes in the second period under which procuring from multiple suppliers (split award) is optimal in the first period.

On the empirical side, a systematic study of episodes of vaccine shortages or declining vaccine prices, globally or in India, will enable us to understand factors that may result in price or quantity shocks. Procurement data from UNICEF, WHO and particular countries will be analysed to understand long-term trends. Finally, using information on procurement policies of different agencies /countries, and their procurement data we will attempt to identify links between policy and outcomes.

5.4 An Analysis of PM Jan Aushadhi Scheme: A Multi-site Study

The primary objective of the study is to evaluate the flagship scheme of 'Pradhan Mantri Bharatiya Janaushadhi Pariyojana' (PMBJP), with a special focus on effectiveness and outreach to the target population and its delivery and inclusion. The fundamental research question pertains to what is the correlative relationship between income and generic-related health-seeking behavior. The second question pertains to the operative significance, with special attention towards the socially and economically marginalised sections. Furthermore, the study aims to shed light on the impact of digitization and e-pharmacies on the accessibility of generic medicines, analyzing their role in bridging the urban-rural healthcare divide. Amidst the evolving landscape, understanding the cultural nuances influencing healthcare choices becomes paramount.

5.5 An Evaluation study of Ayushman Bharat in Rural Haryana

5.4 THE IMPACT OF MEDIUM OF INSTRUCTION ON LEARNING OUTCOME

Nearly 40% of the world's population does not have access to education in their own language. Children whose mother tongue is very different from the medium of instruction in school find it hard to understand and make full use of study material and class lectures. These difficulties may compound over the years, leading to lower educational attainment and wage inequality based on linguistic groups. The literature on cognitive neuroscience and educational psychology suggests that instruction in the mother tongue may be especially important for first-generation students in the earliest years of their education, especially in resource-poor environments.

In this project, we use primary data from Bihar villages and secondary data from the Census of India to estimate the impact of linguistic distance on learning. Our findings thus far suggest linguistic distance matters most when it is combined with spatial isolation of households whose language of instruction differs from their home language
